

# FWC closes recreational lane snapper harvest in Gulf state waters

At its December meeting, the Florida Fish and Wildlife Conservation Commission (FWC) issued an executive order to close the recreational harvest of lane snapper in Florida Gulf state waters starting Dec. 13. Harvest will remain closed through Dec. 31, and will reopen on Jan. 1, 2025, consistent with the closure in adjacent Gulf federal waters.

Consistent state and federal recreational seasons for lane snapper will help prevent overfishing and quota overages.

FWC modified Gulf greater amberjack recreational season to be open Sept. 1–Oct. 31 each year

At its December meeting, the Florida Fish and Wildlife Conservation Commission (FWC) approved a rule to modify the recreational season for greater amberjack in state waters of the Gulf of Mexico to be consistent with the new season in adjacent Gulf federal waters. The recreational season for greater amberjack in Gulf state waters will open Sept. 1 through Oct. 31, each year.

The Gulf greater amberjack stock is overfished and experiencing overfishing, and the modified season is intended to reduce harvest and help improve the status of the stock. The modified recreational season also provides additional protection during the greater amberjack spawning period from March through May.

The modified Gulf greater amberjack recreational season will go into effect April 1, 2025.


Recreational harvest of red grouper and lane snapper opens in Gulf state waters Jan. 1

Harvest of red grouper and lane snapper will open in Gulf state waters on Jan 1.

If you plan to fish for red grouper in Gulf state or federal waters from a private recreational vessel, you must sign up for the <u>State Reef Fish Angler Designation</u> (annual renewal is required). This annual designation allows you to be selected to receive a mail survey for the State Reef Fish Survey. By participating in the State Reef Fish Survey, you are improving recreational data that are used to provide optimum recreational fishing opportunities in Florida.
